

- The fund is subject to equities risk, risk to capital and income, foreign currency risk and risks of investing in emerging markets.

### Investment Objective 投資目標

The fund aims to achieve capital growth over time. The fund invests at least 70% (and normally 75%) of its assets, in equities of companies that are listed, headquartered, or do most of their business in the Asia Pacific region, including, but not limited to, Japan, Australia, China, Hong Kong, India, Indonesia, Korea, Malaysia, New Zealand, Philippines, Singapore, Taiwan and Thailand. The fund invests at least 50% of its assets in securities of companies with favourable environmental, social and governance (ESG) characteristics. (Please refer to the offering document for Investment Objective of the fund)




