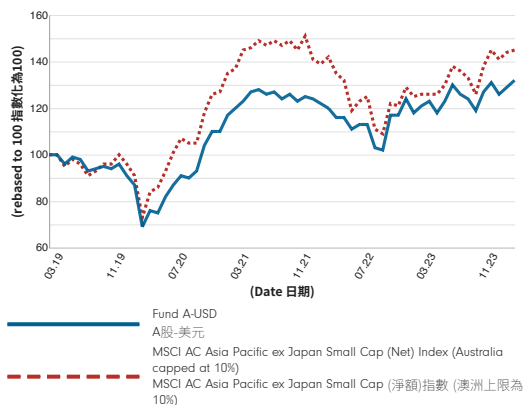
- This fund invests primarily in smaller companies' equity securities in Asia Pacific (excluding Japan).
- The fund is subject to equities risk, risk to capital and income, foreign currency risk and risks of investing in emerging markets.
- The fund may invest in medium and small companies. Equities of small and mid capitalisation companies can be more volatile to adverse economic developments and less liquid than those of larger companies.
- The use of ESG criteria may affect the fund's investment performance and may result in a return unfavorably to similar products without such focus. The fund aims to achieve capital growth over the long term. The fund invests at least 70% of its assets, in equities of smaller companies that are headquartered, or do most of their business, in Asia Pacific (excluding Japan), including emerging markets. The fund invests at least 50% of its assets in securities of issuers with favourable environmental, social and governance (ESG) characteristics. 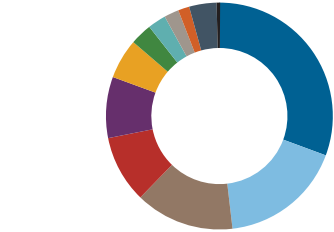

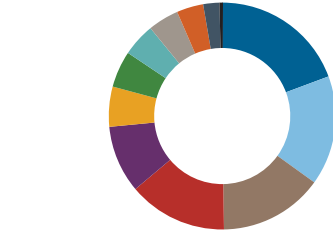
